Bicester Village Employee Referral Scheme – Referral Terms

1. General

- A. The employee referral scheme (Referral Scheme) is operated by Value Retail Management (Bicester Village) Limited, company number 02884096 with registered office at Management Suite, Bicester Village, 50 Pingle Drive, Bicester, Oxfordshire, OX26 6WD, United Kingdom (Value Retail).
- B. The Referral Scheme operates for the period shown in the Referral Form (the Referral Period). Interviews must take place during the Referral Period, and referrals made outside the Referral Period will not qualify for Rewards.

2. Definitions and Interpretation

In these Referral Terms, the following definitions apply:

Eligible Employer means any of: (i) the companies operating, from time to time, the boutiques, eateries or restaurants at Bicester Village; ii) Value Retail; or (ii) Value Retail Management Ltd..

Management Level Employee means all positions from supervisor upwards (supervisor, floor manager, assistant manager, Store Manager or similar) that involve people management;

Non-Management Level Employee means all positions at sales assistant level or less (sales assistant, stock assistant, cashier or similar) and not involving people management;

Referral Form means the referral form overleaf to be completed as indicated by the Referrer and the Referred, and verified by the Store Manager;

Referrer means any UK-based employee of an Eligible Employer who refers a Referred in accordance with these Referral Terms;

Reward means a £100 Bicester Village gift card (where the Referred joins as a Non-Management Level Employee) or a £300 Bicester Village gift card (where the Referred joins as a Management Level Employee) as further described in paragraph 4; and

Store Manager means the store manager of the Eligible Employer that hires the Referred (or, in the case of Value Retail or Value Retail Management Ltd., the Referred's line manager).

3. Eligibility and Referral Scheme

- A. The Referral Scheme is open to UK-based employees of any Eligible Employer.
- B. For the Referrer to be eligible for the Reward, the following process must be followed:
